

"Carrier to Classroom: transferring military skills into a career in education"

He served as the top enlisted man on a 5,500 sailor nuclear powered aircraft carrier, serving as the key enlisted leader and manager for the ship's captain. He would later build and lead his own charter school. It wasn't long after his 1968 high school graduation that Charles "Chuck" Baldwin walked into the Navy recruiter's office.

Beginning with basic training at Great Lakes Naval Station near Chicago, the Navy taught him that initiative and willingness to learn translates to rank and greater responsibility. It's a lesson held close to his heart during 25 years of service. His journey up the chain of command to chief petty officer, master chief, command master chief of CVN 69 USS Dwight D. Eisenhower, and one of the finalist candidates for Master Chief Petty Officer of the Navy, is a testament to his leadership and management skills.

Fewer than two percent reach the Navy's top enlisted rank. Only a small percentage of those reach leadership at the command level, and fewer still are considered for the highest enlisted role in the entire Navy. The Navy's reliance on its chiefs was summed up in the September 2005 exhortation by Admiral Mike Mullen, Chief of Naval Operations, in the Navy Times, "Chiefs, Run the Navy."

Still in his early 40s after a successful career, Baldwin looked forward to creating a second career on land. After leaving the Navy in 1993, his decision to continue teaching led to his hiring as an ROTC instructor, later serving as a public school principal.

Within 10 years he decided to build and lead his own school and served as commandant of Delaware's first military affiliated public charter school, the Delaware Military Academy. Not in an existing building -- but in a new, dedicated school, which required raising \$12 million, establishing a curriculum and hiring instructors, many of whom were military veterans. Today the school is thriving with a long waiting list of applicants.

Baldwin later served as president of the Charter School of Wilmington, one of the first independently operated public schools in the United States, established in 1996 with a focus on mathematics and science until his retirement in 2013. He was most recently instrumental in the 2015 creation of the First State Military Academy in Clayton, Del., which is affiliated with the U.S. Marine Corps.

His book, based on his Navy and educational experience and a master's degree in school leadership and instruction, is geared to the veteran wanting to become a classroom teacher, whether in the private or public sector. Its 10 Deckplate Leadership (DPL) lessons not only apply to schools but to the corporate world as well.

He also serves as a member of the Delaware Commission of Veterans Affairs and is a board member of the Friends of Delaware Veterans, Inc., the official fundraising organization of the Delaware Veterans Trust Fund. The Trust Fund was created to assist honorably-discharged veterans of all generations in financial emergency. It provides a one-time, hand up for veterans residing in Delaware.

In a remarkable continuation of his career-long leadership, Baldwin is donating the proceeds of "Carrier to Classroom," to the Veterans Trust Fund.

The radio call sign "Dustoff" originated as the call sign for the helicopter units dedicated exclusively to evacuating wounded from the battlefield. By 1966, there were several Dustoff units in various locations in Vietnam. A Dustoff mission was three times more dangerous than any other helicopter mission. During eleven years of conflict, 211 crewmen died. If asked to pull back under fire, Dustoffers response was "when we have your wounded." From 1962 to 1973, a total of 496, 573 missions were flown carrying over 900, 000 patients. The average time to transport a wounded patient to a hospital was less than one hour. Less than 1% of American wounded who survived the first 24 hours died.

Dustoff crews flew virtually unarmed as they attempted to land in some of the tightest and most difficult terrain under enemy fire and in some cases in weather that would ground most aircraft crews. When no LZ was available, Dustoff would hover at treetop and hoist the wounded from the ground to the helicopter maintaining an easy target for the enemy. Ground troops held Dustoff in very high esteem because they knew the "Dustoff Boys" would always come for them.

The Dustoff motto was and is, "No hesitation, no rationalization, no compromise-Fly the Mission."

This year's Dustoff Association Reunion was held by the VVA Chapter 850 of Dover, DE. The weekend events were a great success thanks to Paul Davis, Dave Skocik, Joe Startt Jr. and many great members of Chapter 850. Delaware gave a warm welcome to all these real heroes, from Governor Carney, Lt Gov. Hall-Long, General Vavala and many more. Great admiration was shown to all our courageous pilots, crew chiefs and medics.

New tele-ICU monitoring service deployed at Wilmington VA



Modernization and innovation are top priorities for VA health care. A new, state of the art program, integrating telecommunications technology with intensive care physicians who are on duty around the clock in a remote location hundreds of miles away was kicked off at the Department of Veterans Affairs Medical Center in Wilmington, Delaware. The new program is designed to enhance health care services for Veterans Affairs patients.

A ribbon cutting ceremony highlighted the new two-way real time video links between each of the six ICU rooms and two emergency department rooms at the Wilmington VAMC and ICU specialists at the Cincinnati VA Medical Center. The link provides another layer of care for patients by connecting them via real-time video links to specialists in Cincinnati who are available 24 hours a day, seven days a week. The tele-ICU team has a supportive role; they have an overview of all the patients in the unit and can alert the bedside staff if any problems occur.

As part of the program, bedside data from patients at the Wilmington VA is made available to nurses and doctors in the Cincinnati monitoring center. Vince Kane, director of the Wilmington VAMC said the technology is especially important in enhancing medical care provided to veterans served by the Wilmington VA.

"We are very excited for the opportunity for us to apply best practices focused on making sure we meet the needs of our veterans," said Kane. "By having access to the team in Cincinnati, our providers and nurses have additional eyes and expertise to help enhance Veteran care."

The tele-ICU partnership connects Wilmington staff and patients with the Cincinnati's monitoring center, which is an advanced tele-health facility where remote intensive care physicians and nurses support the care of ICU patients by using virtual technologies and clinical information systems. Critical care nurses staff the Tele-ICU Monitoring Center 24/7 with critical care physicians available overnight and weekends. The remote providers have access to bedside clinical data, can assess a veteran through video conferencing technology, and can provide consultative recommendations or directly intervene in patient care as desired by the local ICU staff.

Dr. Callahan, intensivist at the Wilmington VAMC ICU, said the program will provide additional layers of professionals providing more care locally. The services allow for continuous monitoring of patients receiving ICU care, even when local providers are out of the room assisting with other critical patients.

Kelley Bowens, ER ICU nurse manager at Wilmington VA said the new program will provide remote vital checks on local patients, allow distance providers to virtually make rounds in the patients' rooms and monitor changes that might be going on with veterans' vital signs. If there is an issue with a patient, local ICU staff will be alerted allowing for a fast response to the patient's changing medical condition. The new service enhances the face-to-face care which is already being provided to patients.



Sussex County VA Clinic Officially Opened

The Department of Veterans Affairs Sussex County Community Based Outpatient Clinic (CBOC), currently located in the Georgetown Plaza officially relocated on Sept. 12th. The new clinic, located at 21748 Roth Ave., Georgetown, Del., is across the street from Del Tech Community College.

Past News Article: "We have gotten the green light on all of the systems at the new location and we are ready to start seeing veterans," said Jake Spruance, interim associate director for operations at the Department of Veterans Affairs Medical Center in Wilmington, Del. "This new clinic was designed specifically to improve access to care, enhance work areas in the clinic and provide veterans in lower Delaware with a clinic they can be proud of."

The new location has ten primary care exam rooms, eight behavioral health consultation rooms; three dedicated telehealth rooms, two medical specialty, two clinical procedure rooms, and two dedicated women's health rooms. The clinic is approximately 10,000 sq. ft., which is 2,500 sq. ft. larger than the current building. The additional space allows for future expansion of services to meet the needs of veterans.

"This new facility is further evidence that the VA recognizes the growing number of veterans in lower Delaware and is committed to providing them the best health care available," said Vince Kane, director for the Wilmington VAMC. "We are also working on plans to expand the specialty services offered including additional telehealth options to ensure veterans have timely and convenient access to high quality care. I know our dedicated staff are excited about the new space and opportunities to provide more services to veterans who call lower Delaware home."

The VA has been communicating with local veterans organizations to announce the opening which will take place on September 12. "To assist with the transition, appointment letters are being mailed to veterans who have upcoming appointments that include the location of their appointments," said Christine O'Donnell, chief of health administrative services at the Wilmington VAMC. "Beginning Sept. 12, veterans with scheduled appointments at the VA Sussex County CBOC should report to the Roth Ave. location. "VA Services offered at the new clinic include Primary Care, Comprehensive Women's Health, Laboratory Services, Telehealth Services (including tele-retinal, tele-dermatology), Podiatry, Psychiatry, Behavioral Health counseling, and Social Work.

The Wilmington VA Medical Center's sole purpose is providing world-class health care to America's Veterans. If you are a Veteran, you may be eligible to receive care and benefits from the U.S. Department of Veterans Affairs. To learn about eligibility and enrollment visit www.vets.gov.

Veteran Transition: Credentialing veteran MOS's to Delaware's workforce.

Finding employment after leaving military service can be a daunting task for many veterans. Over the years local, state, and federal governments along with the Department of Defense have developed programs and educational services to support service members that are exiting the service and entering the civilian workforce. However, can we be doing more to assist with helping veterans in Delaware find employment? In short, there is. It is un-arguable; service members are the most disciplined and extensively trained. Many employers are looking for these veterans. The catch is that most veterans leave the service with the same amount of professional credentials as when they came into the service. Which for most is none, excluding medical professionals and others (doctors, physiatrist, etc.).

The reason is military occupational specialty (MOS) qualifications and private/state qualifications are different and are not transferable. For example, a service member who has extensive training and experience in driving a truck and trailer (rig) is not qualified to drive one in the civilian sector. State laws and requirements do not allow veterans to transfer their MOS as a truck driver to a CDL within the state. This goes for other MOS's that can help in the growing industries here in Delaware. Major industries found in Delaware include; aircraft industry, healthcare, environmental, financial and other growing professional industries (NewsMax, 2015). Many MOS's found in the military can meet the needs within these industries. What can be done? Currently the veteran unemployment rate in Delaware is 6.1%; roughly 4,580 veterans (Census Bureau, 2015). Advocating for the State of Delaware and other professional credentialing agencies to find ways to accept MOS credentials or stream line the training process to credential veterans who have extensive experiences in their fields, can reduce the veteran un-employment rate and better business's here in Delaware. 

The Delaware General Assembly will host the 4th annual Wreaths Across America ceremony on **Monday**, **December 11**, **2017 at 11:30 a.m.** The public is invited. State House ceremonies in all 50 states and Washington D.C., are part of a week-long celebration of America's veterans and their service to our country, with a particular focus on family during the holidays.

"This nationwide program is about remembering our fallen heroes, honoring those who serve, and teaching our children about the sacrifices made by veterans and their families to preserve our freedoms," said event organizers. The originator of the wreath laying program was Morrill Worcester, owner of a wreath making company in Maine who in 1991 donated and delivered wreaths to Arlington National Cemetery to be placed on the graves of the fallen.

The WAA program's mission of "Remember, Honor, Teach," spreads the message of the importance of remembering our fallen heroes, honoring those who serve, and teaching our children about the sacrifices made by veterans and their families to preserve our freedoms. A large wreath honoring all five branches of the armed forces will placed at the base of the Delaware Continentals Statue. Additional wreaths will be laid on the grounds of Legislative Hall, at the Gulf War Memorial, the Dover Light Infantry Memorial Wreath, the World War II Memorial, the new World War I Memorial (which will be dedicated on November 4, 2017) and the Medal of Honor Memorial. Our Disaster Relief Program supports veterans, service members, surviving spouses and their families during times of great need in the aftermath of isolated/specific disasters. The Midwestern and Eastern floods, Western fires, and Central tornadoes are just some of the disasters which have recently impacted veterans and their families.

DAV disaster relief grants—for which available grant amounts recently doubled—may be issued for the purpose of providing financial aid, food, clothing and temporary shelter. DAV supply kits—which include backpacks, blankets and hygiene kits—are also provided, providing an additional resource for safety, comfort and self-sufficiency in an extended emergency, disaster or evacuation. The hygiene kit includes basic necessities like a toothbrush and toothpaste, razors and shaving cream, hand sanitizer, deodorant, shampoo and soap.

Disaster Relief Eligibility Criteria:

- The applicant must be an ill, injured or wounded veteran or the spouse thereof (Same household); or a surviving spouse in receipt of Death Compensation or Dependency and Indemnity Compensation (DIC); or a surviving spouse of a former Prisoner of War (POW); or a surviving spouse of an ill, injured or wounded veteran as a result of the isolated/specific disaster.
- The applicant does not need to be a member or in receipt of service connected compensation to be eligible.
- The applicant must be the victim of either an isolated or specific disaster.
- The applicant must be in immediate need of financial assistance, at the time of the disaster, as they do not have available funds, to pay for acquired
 expenses, Example: Veteran is covered by homeowners insurance, but will not receive compensation from the insurance for the incident until several days out.

To apply for Disaster Relief, please contact your local DAV National Service Officer (NSO).





The effect of military service can be profound and lasting. There are a number of financial, social and health issues that result from military service. Some Wounded Warriors and Veterans who have a compensation rating of 100% P&T are unaware that Social Security may expe-

dite the processing of their disability claims.

Benefits available through Social Security are different than those from the Department of Veterans Affairs and require a separate application.

The expedited process is used for military service members who become disabled while on active military service on or after October 1, 2001, regardless of where the disability occurs.

Starting March 17, 2014, veterans who have a VA compensation rating of 100% permanent and total (P&T) may receive expedited processing of applications for Social Security disability benefits.

What do I need to know about the VA & Social Security programs?

Both Social Security and VA pay disability benefits. However, their programs, processes and criteria for receiving benefits are very different.

A VA compensation rating of 100% Permanent and Total does not guarantee that you will receive Social Security disability benefits. To be approved for Social Security benefits, you must meet Social Security's definition of "disability." To be found disabled:

- You must be unable to do substantial work because of your medical condition (s); and
- Your medical condition (s) must have lasted, or be expected to last, at least one year or to result in death.

If you receive VA compensation, this will not affect your Social Security benefits.

Even active duty military who continue to receive pay while in a hospital or on medical leave should consider applying for disability benefits if they are unable to work due to a disabling condition. Active duty status and receipt of military pay does not necessarily prevent payment of Social Security disability benefits. Although a person cannot receive Social Security disability benefits while engaging in substantial work for pay or profit, receipt of military payments should never stop someone from applying for disability benefits from Social Security.

For those who return home with injuries, Social Security is a resource they can turn to for disability benefits. Social Security's Wounded Warriors website is at www.socialsecurity.gov/woundedwarriors.
